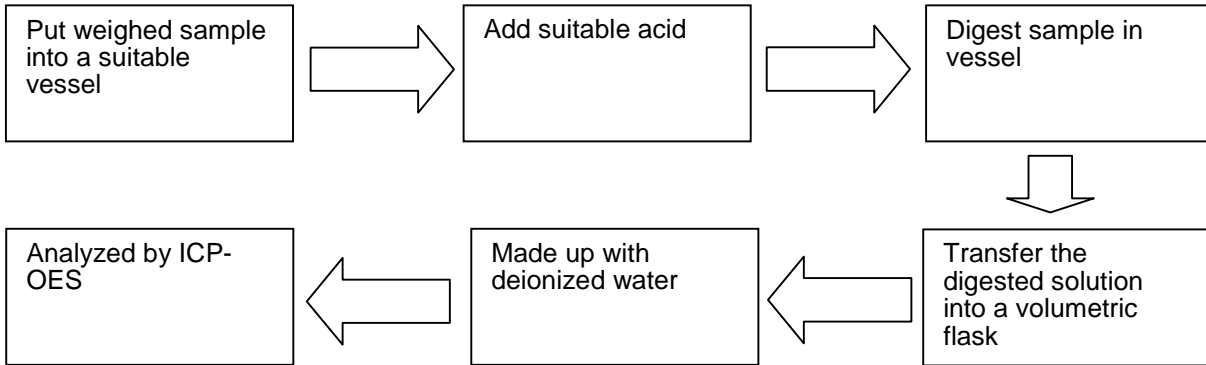

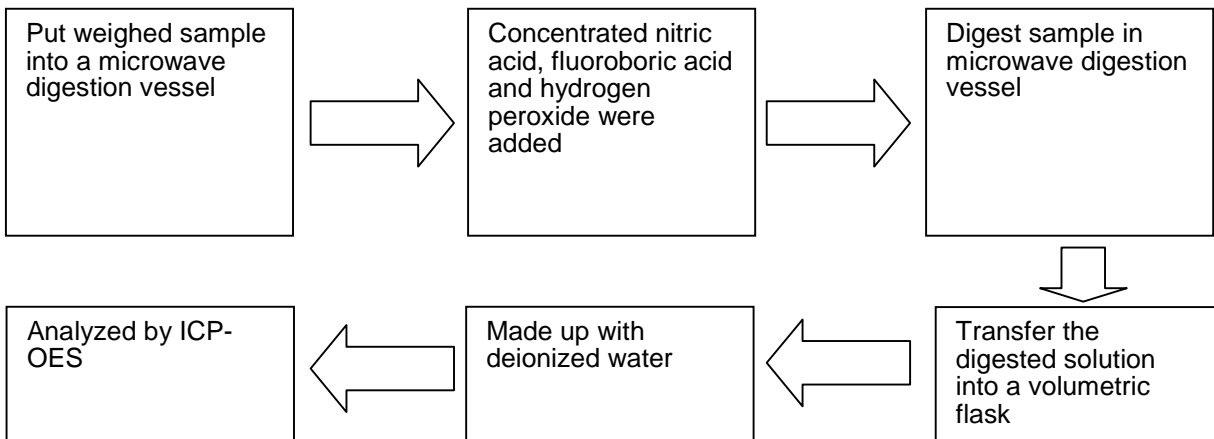

1. Test for Cd/Pb Contents



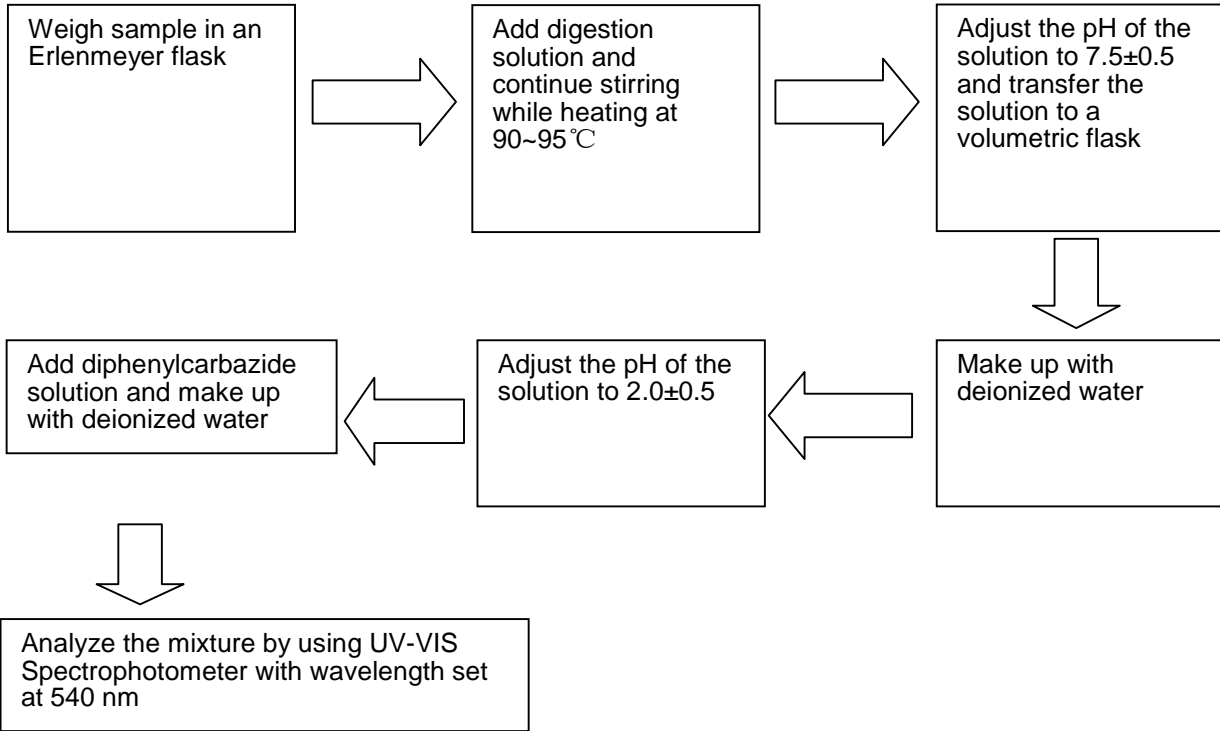

1. Test for Cd/Pb Contents



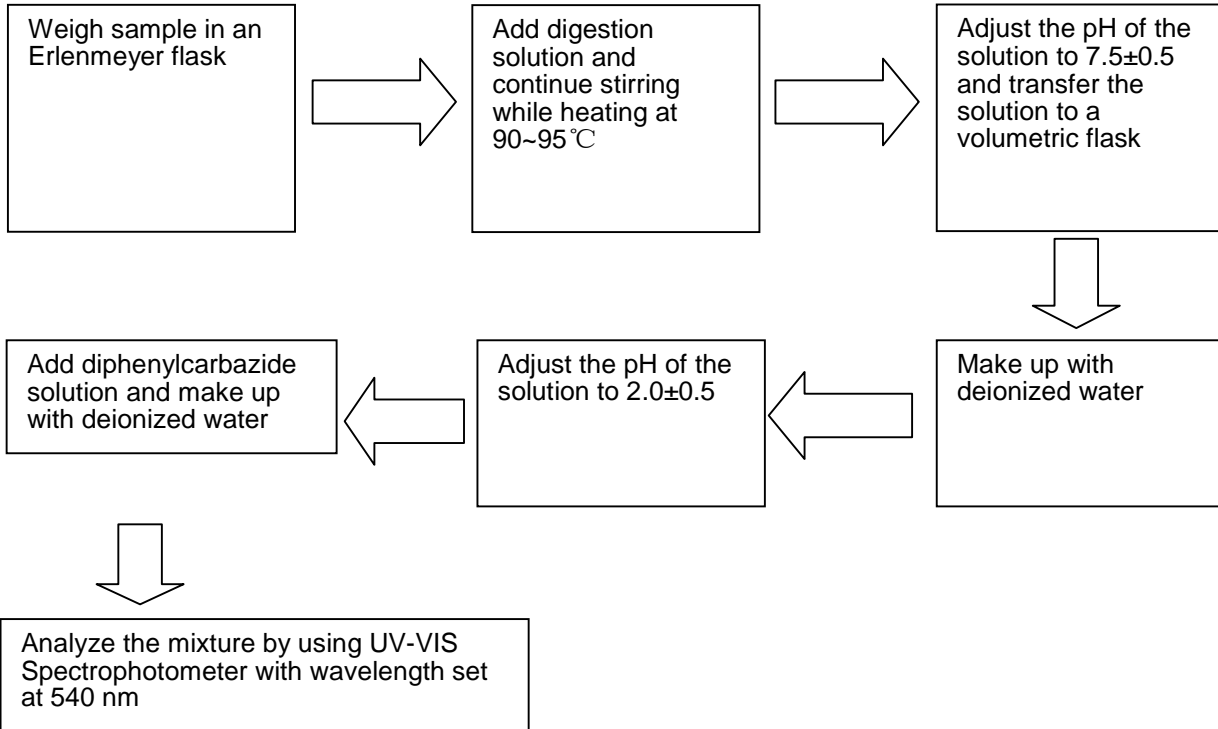

1. Test for Cd/Pb Contents



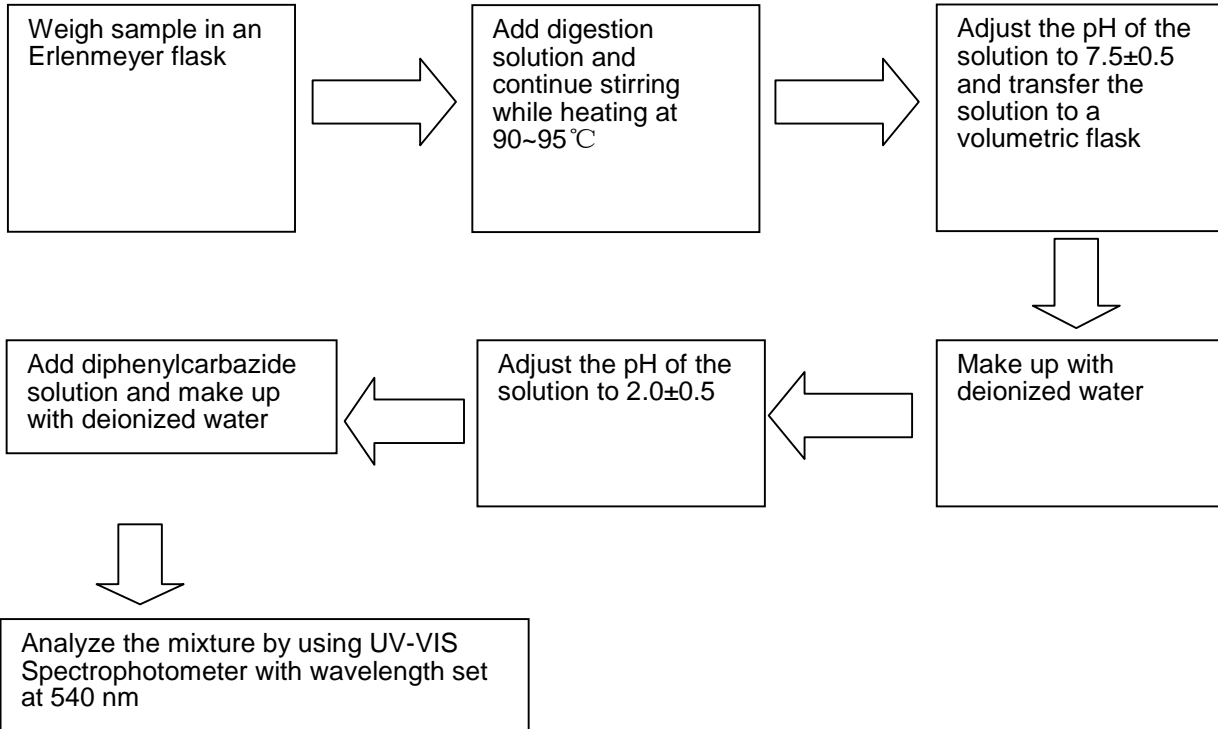

1. Test for Cd/Pb Contents



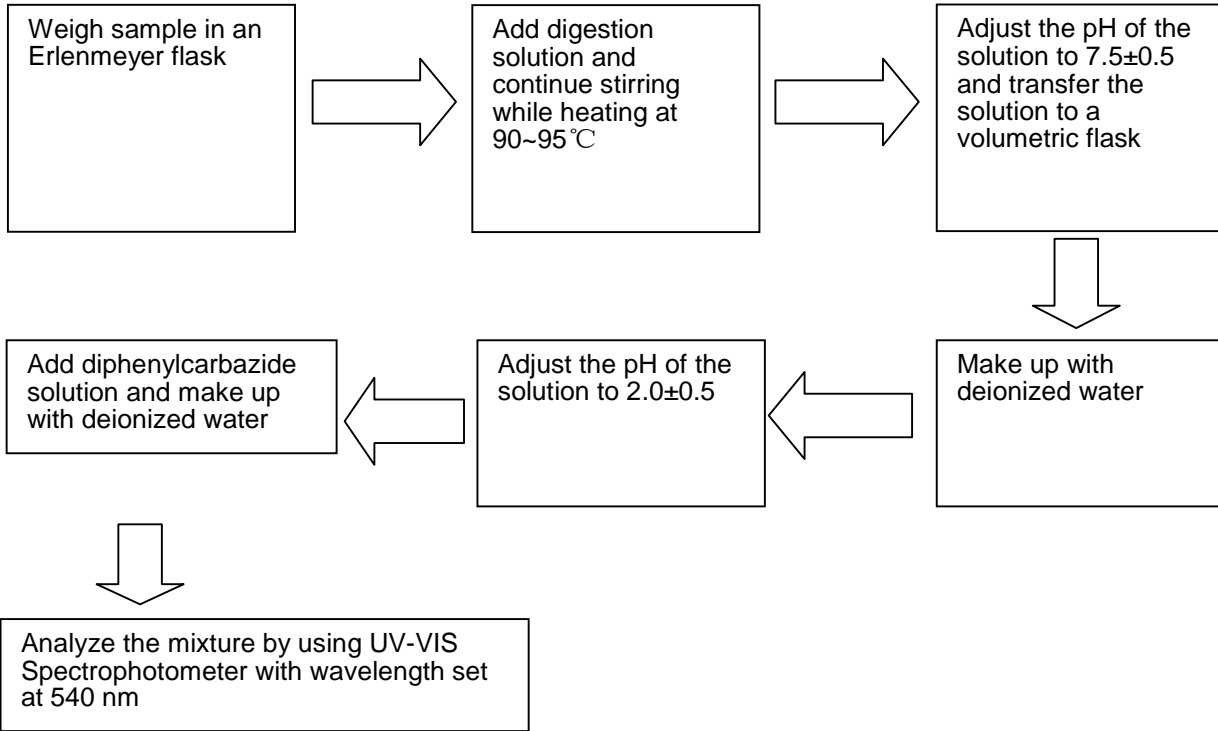

1. Test for Cd/Pb Contents



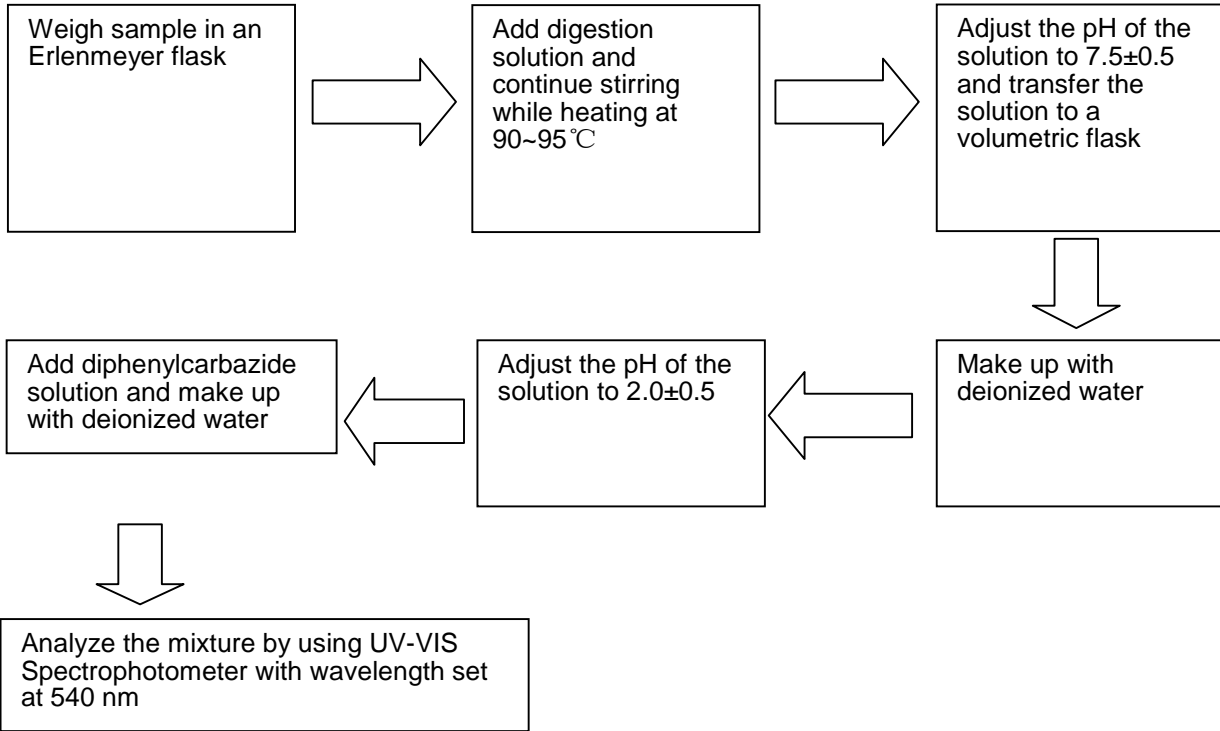

1. Test for Cd/Pb Contents



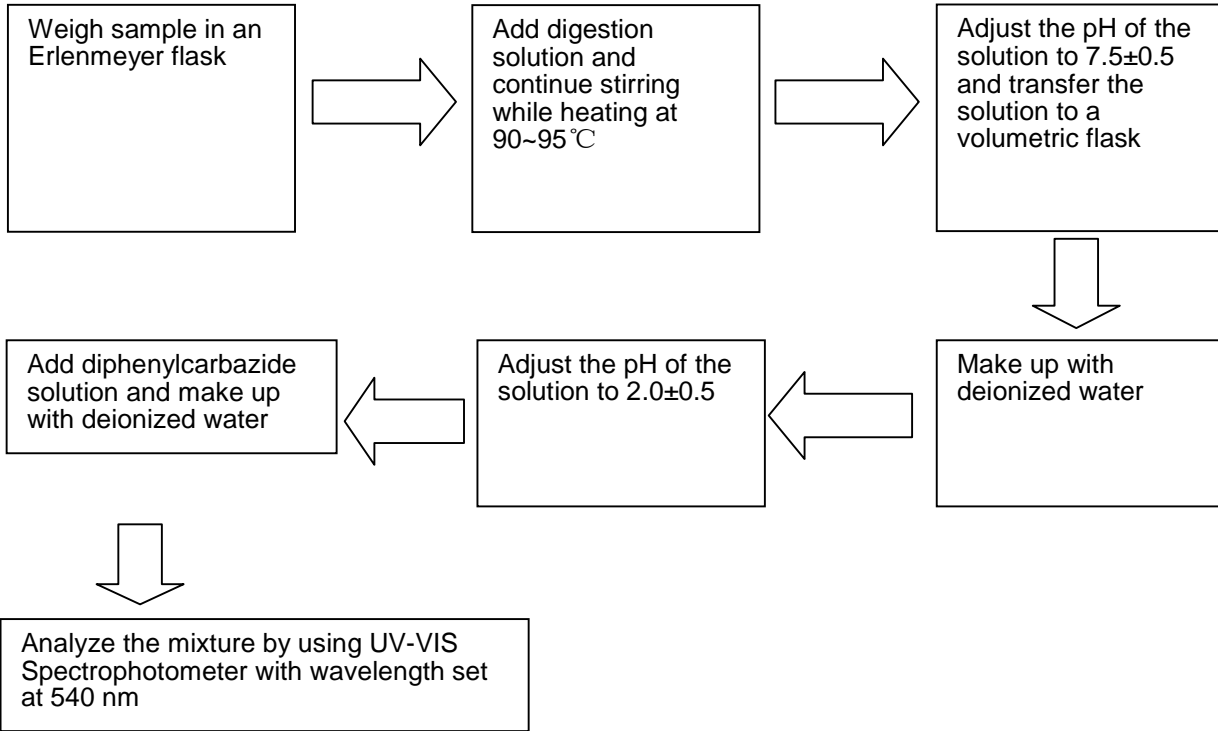

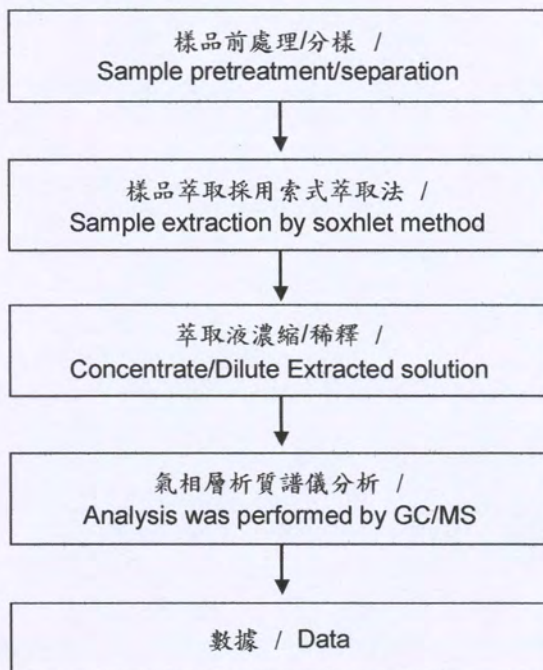
