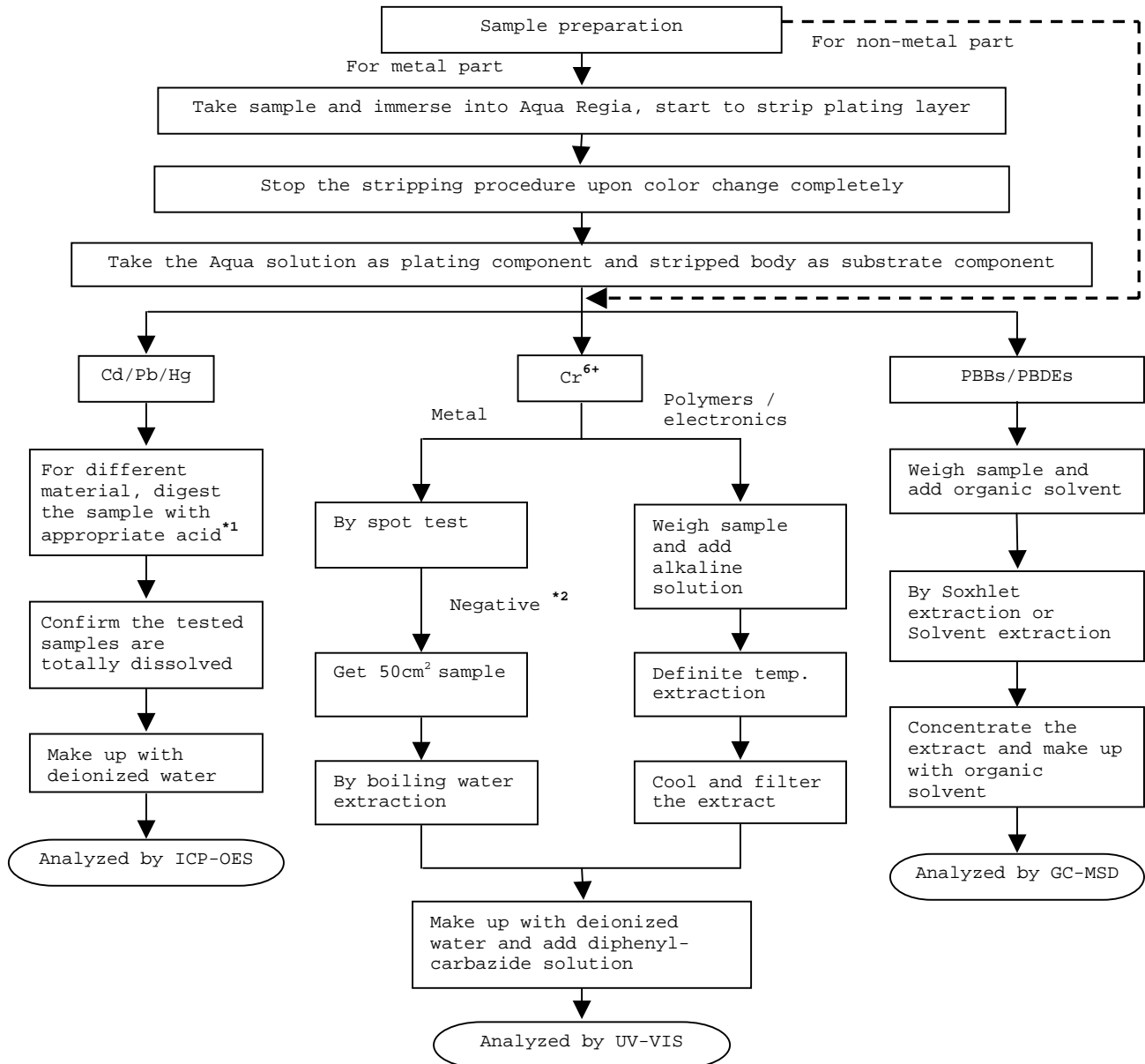

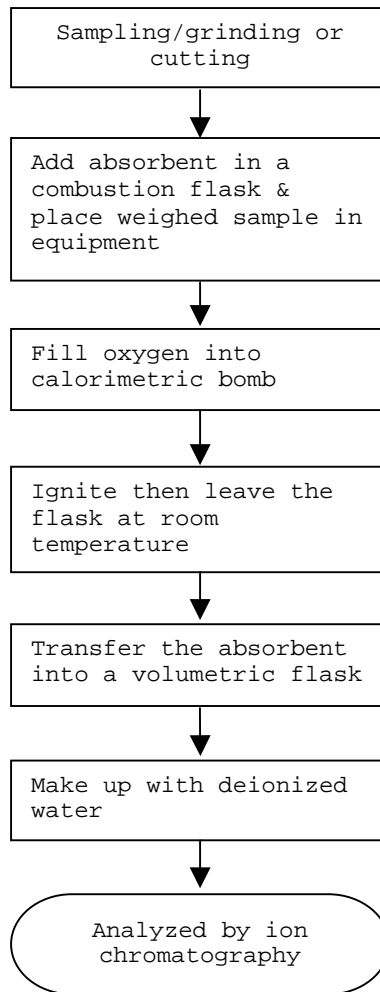

Test for Halogen Content

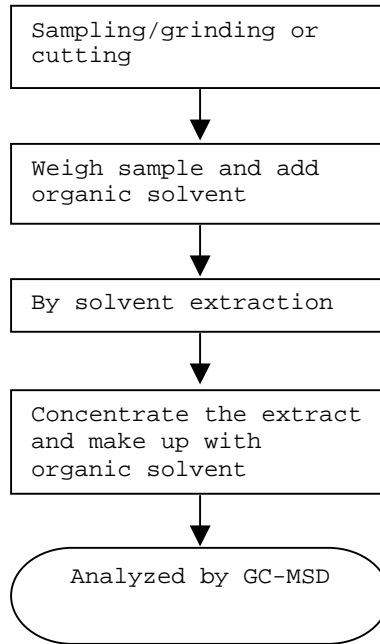

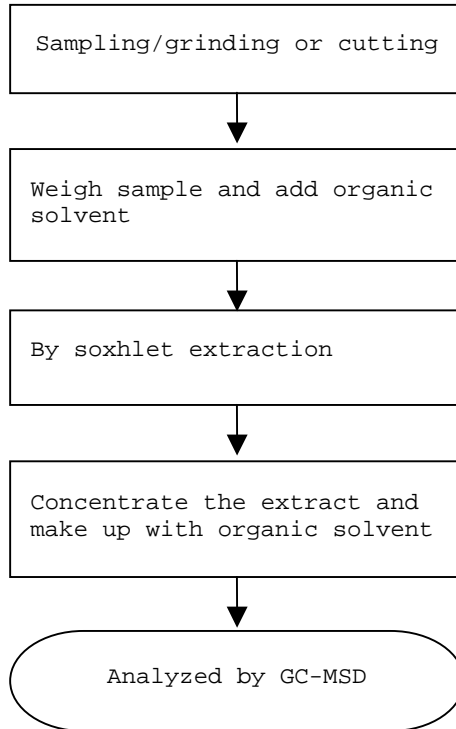

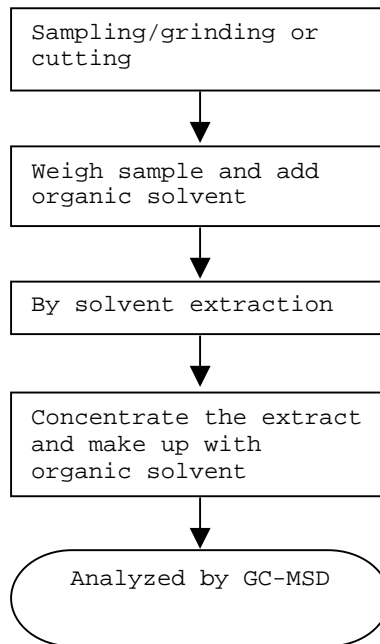

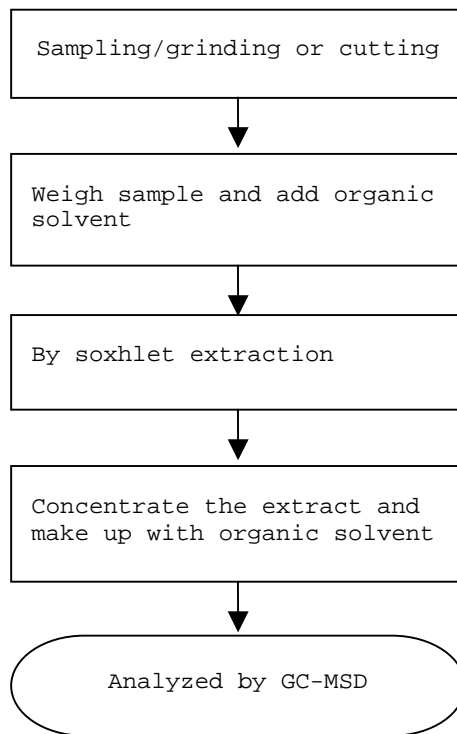

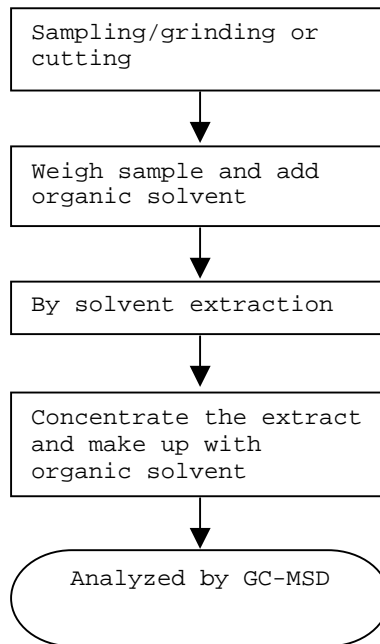

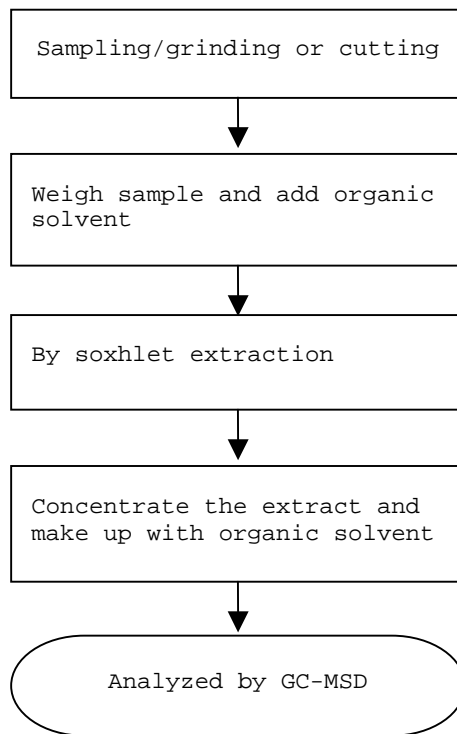

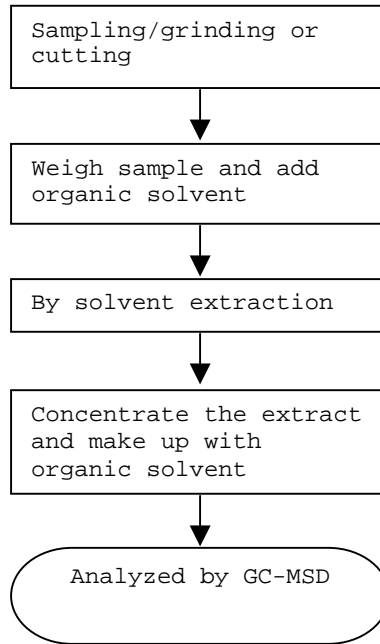

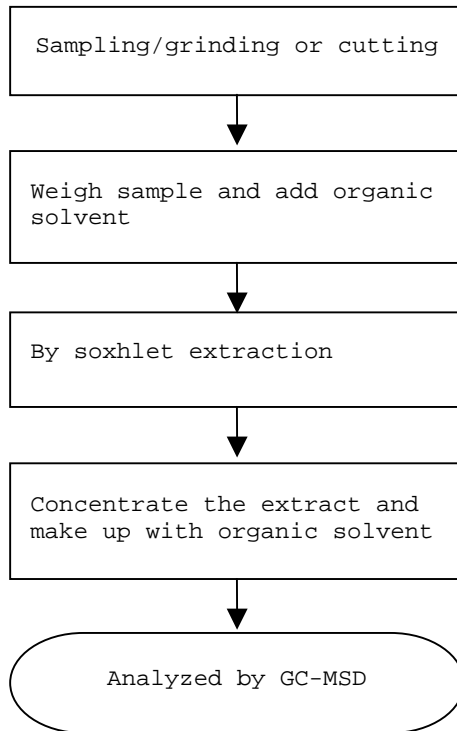
