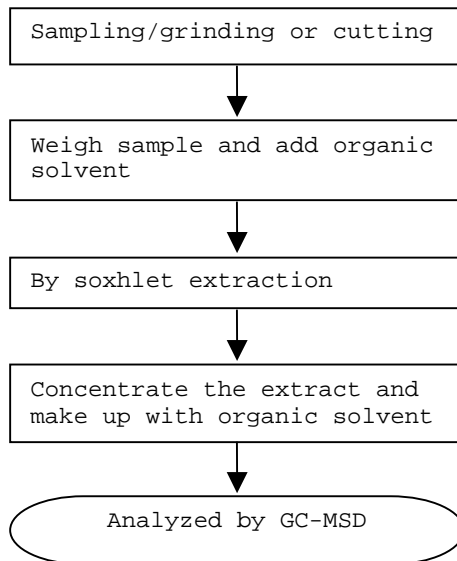

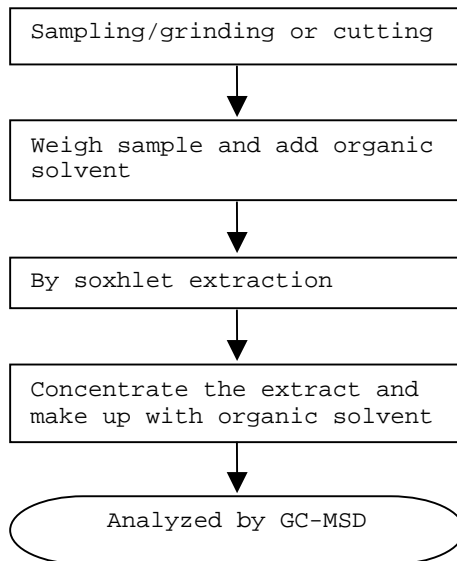

Test for Halogen Content

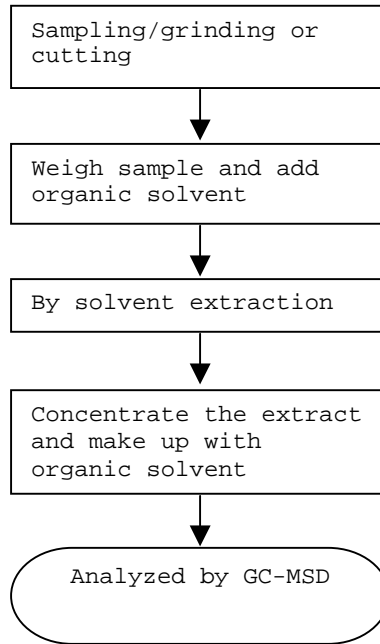

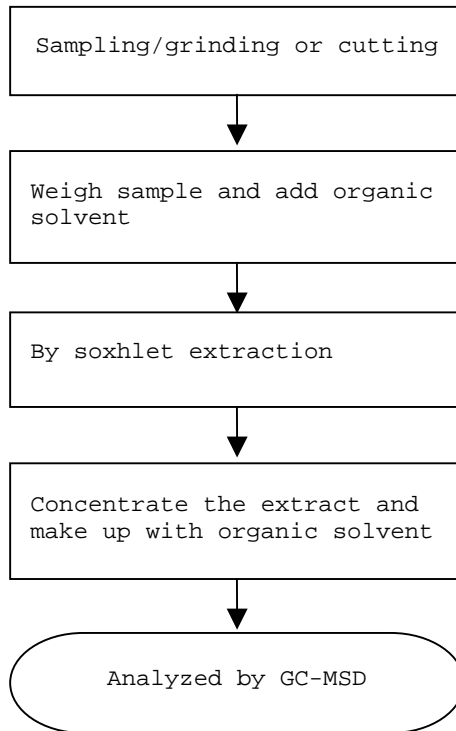
