- LFCP Series Coordination Panels: One (1) year
- LPS Series Shunt Trip Disconnect Switches: One (1) year
- MPU, MPS, FPS, and FPU Industrial Relay Product series: Ten (10) years
- Surge Protective SPD2 and SPDN Series: Two (2) years
- All other Standard Industrial Relay Products: Five (5) years
- Custom and private labeled Industrial Relay Products: Eighteen (18) months

Third-party/pass-through Industrial Products: If applicable, any warranty will be as provided by the product's original manufacturer to the extent such is transferable by Littelfuse to Buyer.

Littelfuse's sole liability is limited, at its option, to repair or replace the product or to credit the purchase price of any product that is returned during its warranty period and proven to have a warranted defect. The assigned RMA number must be marked on the outside of the package. The point of contact for the assigned RMA will be notified of the warranty evaluation results and product disposition.
