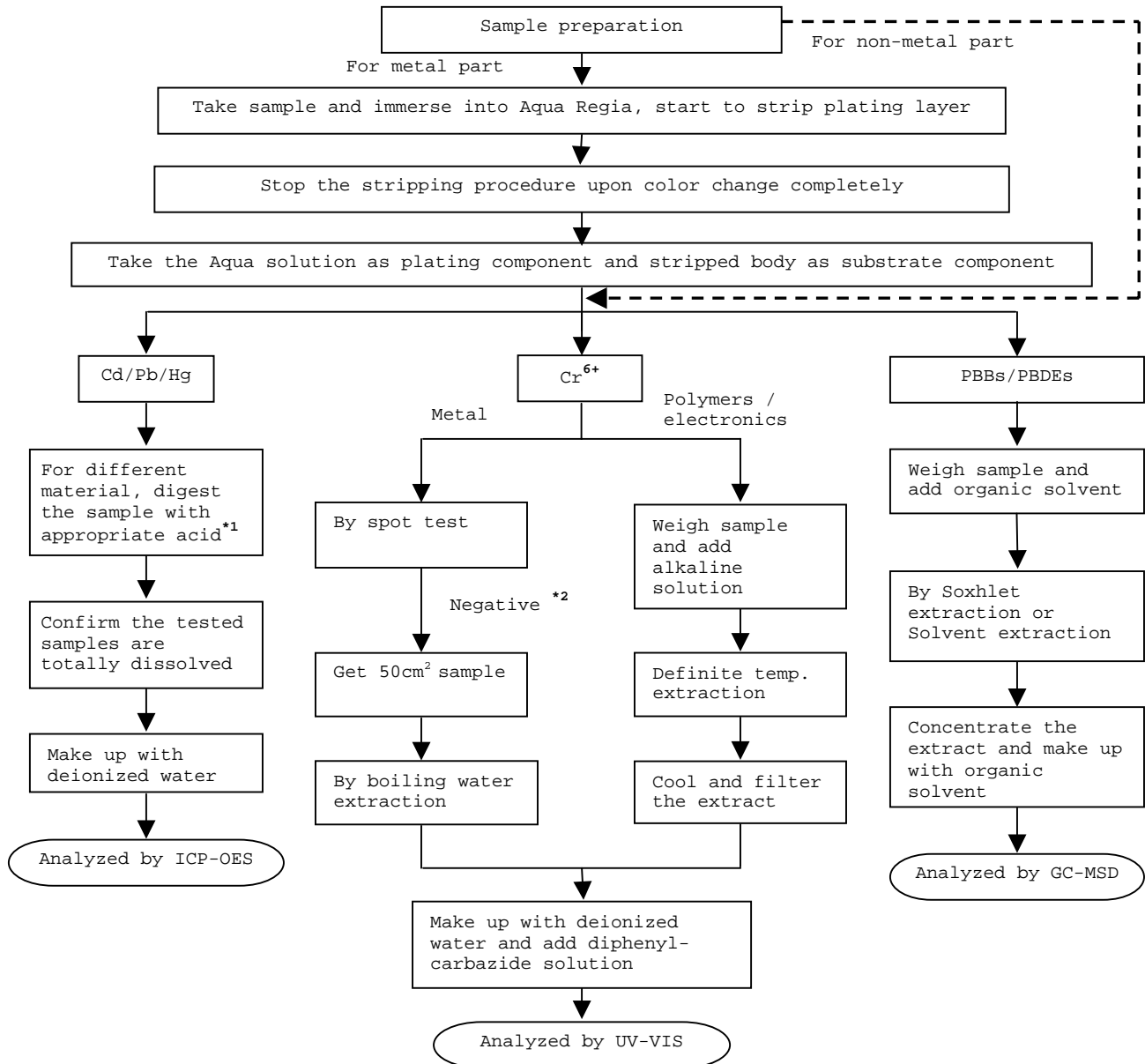

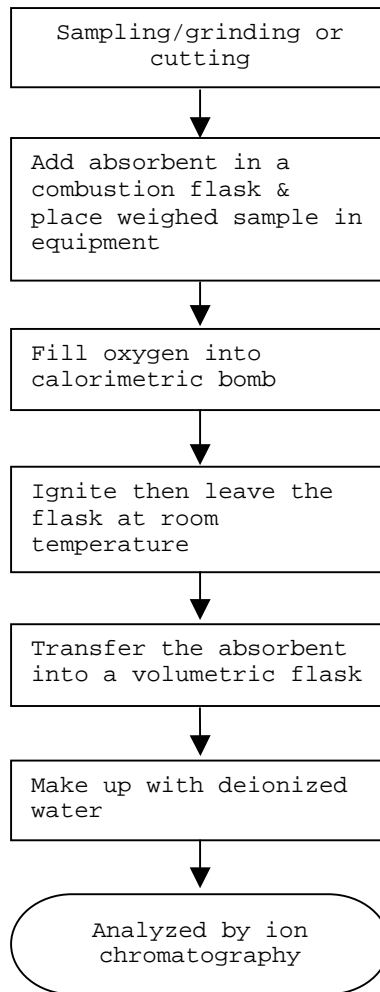

Test for Halogen Content

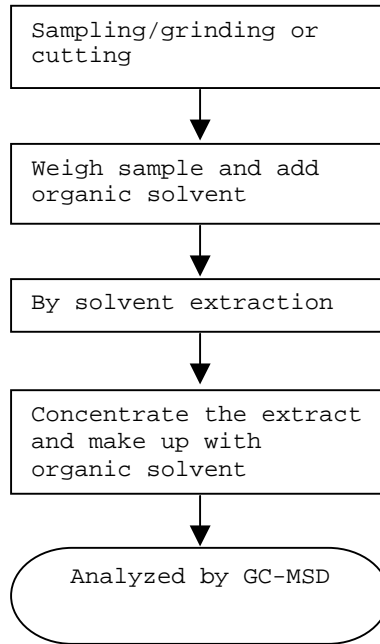

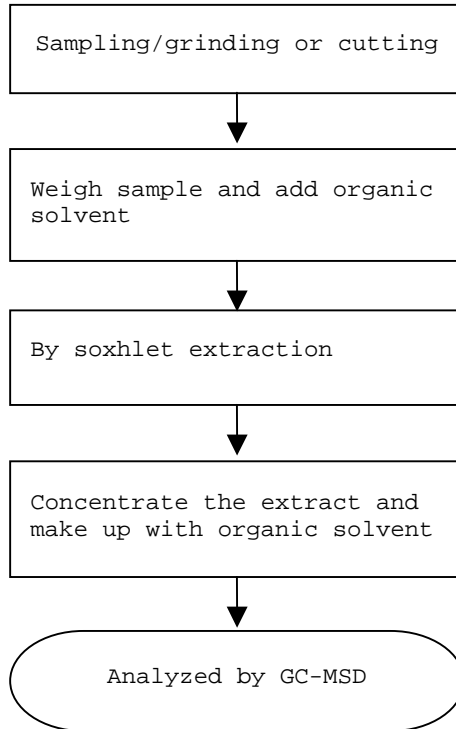

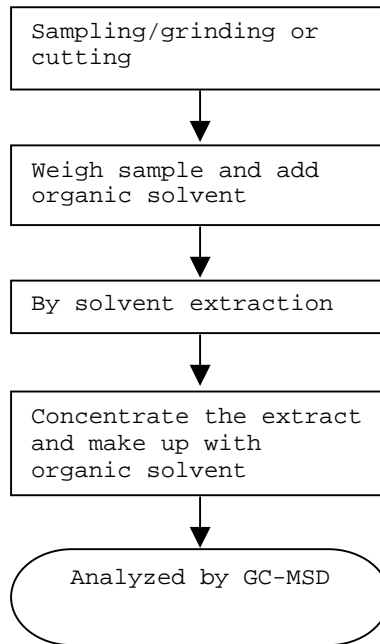

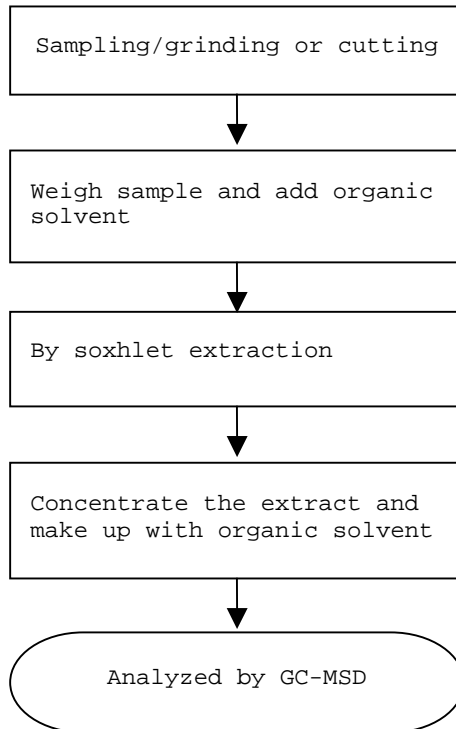
